- Non-student volunteers must be authorized to work in this country.
- I shall defend, indemnify and hold harmless Seton Hall University, its trustees, regents, officers, agents and employees from liability for injury, damage, loss or liability whatsoever caused by my negligence, gross negligence or intentional act or omission.
